Naslov: **Novosti u COBISS3 aplikaciji**

Programska oprema COBISS3 stalno se nadograđuje i dopunjava da bi podržala rad biblioteka. Inicijative za izmene dolaze kako od biblioteka učesnica i njihovih članova, tako i od IZUM-a koji prati trendove u vodećim svetskim sistemima za podršku bibliotekama. Najzad, potrebe za dopunjavanjem bibliotečkih sistema pojavile su se i tokom prilagođavanja društva na pooštrene zdravstvene uslove širom sveta. U poslednje vreme u programskoj opremi COBISS3 pripremili smo neke dopune koje bibliotekama omogućavaju uspešniji i lakši rad.

Novi inventar je odgovor na izazov kako izvesti inventar bez zatvaranja vrata biblioteke ili odeljenja za čitaoce, a da biblioteka pritom skoro nesmetano izvodi pozajmicu i obradu građe. Pritom se inventar izvodi u istom okruženju u kojem protiče i tekući posao, dakle, bez kreiranja paralelnog okruženja za inventar. Biblioteka je prilikom izvođenja ovog novog inventara samostalna i nije joj potrebna pomoć IZUM-a.

Budući da biblioteke nastoje da zadovolje potrebe korisnika, pojavila se i želja da korisnik može sam da odredi gde će preuzeti građu. Zato smo u programsku opremu COBISS3 i COBISS+ uključili funkcionalnost mesta za preuzimanje. Mesto za preuzimanje može biti odeljenje, čitaonica, međubibliotečka pozajmica, pozajmica poštom, grupa pretinaca za lično preuzimanje građe ispred biblioteke ili trgovačkog centra i tako dalje.

Upotreba table za potpisivanje veoma je raširena, zato i u COBISS3 širimo mogućnosti njene upotrebe. Glavna prednost upotrebe table za potpisivanje je da se elektronski dokumenti čuvaju u našem repozitorijumu, a u svakom trenutku su na raspolaganju bibliotekaru. Kada se brišu podaci o članu, istovremeno se brišu i svi njegovi elektronski dokumenti, čime su zadovoljeni uslovi u vezi sa čuvanjem podataka o ličnosti. Dakle, ušteda papira i jednostavno upravljanje tokom celog životnog ciklusa dokumenata.

Title: New features in the COBISS3 application

The COBISS3 software is constantly being upgraded and updated to support the operation of libraries. Initiatives for changes come from participating libraries, their members, as well as from IZUM, where we also follow the trends in the leading global systems for library support. The needs to update the operation of library systems were of course also the result of social adaptations due to the current health situation around the globe. Lately, we have prepared some updates in the COBISS3 software, which enable a more successful and easier operation for the libraries.

The new inventory process is the response to the challenge on how to perform the inventory without closing the library or individual departments to the readers, while the library can perform loan and material processing almost without interruptions. At the same time, the inventory is performed in the same environment as all other day-to-day operations – i.e. without creating a parallel environment for the inventory. While performing this new inventory process, the library is independent and does not require assistance from IZUM.

Because libraries want to help the users as much as they can, there was a request that the users should select any pickup location they choose. And that is why we included the functionality for pickup locations in the COBISS3 and COBISS+ software. The pickup locations can be a department, reading room, interlibrary loan, loan location via mail, group of drawers for personal material pickup in front of the library or in front of a shopping mall, etc.

The use of signature pad has become very popular so we also increased its use in COBISS3. The main advantage of the signature pad is that e-documents are stored in our repository and are always available to the librarian. And when the member data are deleted, all e-documents of the member are deleted as well, which is in accordance with the requirements for storing personal data. This means a lot of paper is saved and the management of the documents during their entire life cycle is simplified.
